Punctele tari ale tezei de abilitare (Strong points of the habilitation thesis):

- 1. The thesis contains a series of excellent results about categories and several interesting applications to categories of comodules over coalgebras. One of the best results unifies and generalizes the celebrated theorems of Ulmer and Gabriel-Popescu. Other results are related to duality theories. The results have been published in good and very good journals.
- 2. A part containing deep results and consequences is Section 5.4, which is related to Hopf-Galois extensions and various associated categories of (co)representations.
- 3. The thesis is very well written. The exposition is clear and the list of references is large. The author presents his ideas and results in a large framework of the research done in the same area by other people.

Punctele slabe ale tezei de abilitare (Weak points of the habilitation thesis):

- 1. The list of papers of the author is consistent. However, the number of his papers published in very prestigious journals is relatively small compared to the total number of papers.
- 2. The thesis should include some ideas of proofs.

Rezultatul votului / observații / concluziile comisiei de abilitare se motivează în continuare (Voting result / observațions / premises for the conclusions of the habilitation commission are as follows)

The members of the habilitation commission unanimously agree to accept the habilitation thesis and recommend to to be conferred to the candidate the habilitation certificate.

A suggestion: the author has been interested in categories of comodules over coalgebras. However, except the results presented in Section 5.4, no interest seemed to be shown up for

applications to (co)representation theory of Hopf algebras. Also indications about such an interest do not appear in the list of problems of future consideration, in part II, about career evolution and development plans. It would be highly recommended that such a topic should be approached, and moreover, applications to quantum groups to be looked for.
