

PUBLIC POLICIES FOR BUSINESS.

THE NORMATIVE DIMENSION IN EUROPEAN CONTEXT

- Abstract-

Both inland and European context of organizing economic activity on the principle of free initiative and on the entrepreneurial basis, demands the public authorities to respond to the task of reforming the legal framework in force in accordance with the strategies and principles of efficient public policy making. This approach is equally challenging and continuous, involving responsibility, high degree of professional training, permanent reaction to the practical and theoretical realities, analysis of the European integration demands and interest in the interdisciplinary field of public administration, with a priority on the legal dimension of the studied processes.

The professional activities that I have carried out, as well as the foresights I have made regarding the development of my professional career, basically support this professional approach.

I am Full Professor, member of the Department of Finance, Money and Business Administration at the Faculty of Economics and Business Administration, University "Alexandru Ioan Cuza" of Iași. I am active member of the European Association for Banking and Financial Law, vice-president of Iași Branch of this association, trainer for Business Law within Body of Chartered Accountants and Authorized Accountants of Romania - CECCAR and former trainer at the Roman Notarial Institute, lawyer - member of the Romanian National Bars Association – Iasi Branch.

I am professor and Jean Monnet chair, holder of the Jean Monnet Chair European Financial Regulation (EUFIRE, www.eufire.uaic.ro), member of the Center for Excellence in European Studies at the University „Alexandru Ioan Cuza” of Iasi and member of Global Studies Research Network (<https://onglobalization.com/about>). Also, I am chief editor for journal CLUJ TAX FORUM and editor for three periodicals, specialized reviewer for 5 reviews (from home and abroad) listed in international

databases and I have been involved as a chairman and member of the organizing committee for more than 20 international university conferences.

Being interested to work with professors from other countries, I tried to update my training through internships documentation and teaching training undertaken abroad (University La Sapienza, Roma - Mai 2001, Britannia School of Business, Londra – Decembre 2008, Universitat Catalunya, Barcelona – October 2009, University of Economics Warsaw, Poland – May 2010, Center for European Studies University of Economics Prague – November 2011, University Paris II Sorbonne – May 2011, Universite Paris XIII May 2011, University of Thesaloniki, Grecia – May 2012, Arel University Istanbul, Turcia – June 2013, National Academy of Kiev-Mohyla, Ucraina – October 2012, University Ca’Foscari Venice – Mai 2014, University Coimbra, Portugalia – June 2015, University of Parma – February 2015, University Bifrost – Iceland June 2016, CDA College Cyprus – Septembrie 2016, University Bologna – November 2017, Universite Bordeaux – April 2018, Tel-Aviv University May 2018, Universitaty Michigan-Flint – octombrie 2018).

University „Alexandru Ioan Cuza” of Iași is the academic institution that opened my horizons and interest in studying and my equal appetite for research work and teaching. University of Bucharest strengthened my knowledge in legal sciences by granting the PHD. *cum laude*.. Foreign universities with which I had the opportunity to collaborate showed me that we are in the research and practice of administrative sciences in Romania, equally persistent and dynamic, bound to contribute, each of us according to their own skills and abilities, to update and streamline the regulatory framework in force.

The results of the research activity were disseminated by presenting 59 papers at specialized academic conferences, of which 41 articles by one author and 18 in collaboration. Of the works of the sole author, 10 were presented as works invited to international conferences organized abroad. The research results are also showed by the publication of 33 articles in BDI-indexed journals and in journals published in recognized prestigious publishing houses, and 51 papers in conferences volumes; 10 papers are published in indexed volumes in the international database and 5 in indexed volumes ISI, 5 articles in indexed ISI Thompson Web of Knowleged journals (out of which 3 in review with impact score), and 12 papers are published abroad.

At the same time, I published 11 specialized volumes, including 4 unique authors and 7 collaborating, 6 university courses and 5 specialized monographs. I provided students with the course notes and teaching materials for all the disciplines in which I

worked. In the nearly 20 years of academic activity, I have developed and disseminated course materials and teaching materials for 9 legal disciplines of interest for the field of administrative sciences, 5 for Bachelor's degree - Business Law, Commercial Law, Labor Law, Financial Law, European Law and 4 for Master - Corporate Law, European Financial Law, Tax Legislation, European Financial and Tax Law.

In the project research framework, I am the director of two research projects with direct international funding and the director of a nationally funded research project, research team member in 4 research projects with European funding, and member of the team project for 5 development projects with POSDRU funding.

I appreciate that the future work of theorist in the field of legal sciences will assume equally specific academics concerns and experienced research tasks, including in-depth investigation, for PhD. coordinator level. Academic career involves, mainly, the transmission of knowledge to students located at different levels of their professional training (bachelor, master, and in this case, doctoral), reflecting a continuous process of training and information for the coordinator professor. I plan to continue training and teaching activities and to improve my academic and research skills. I intend to develop partnerships and collaborations with professors and experts with compatible/similar accumulated experience to those I have already gained.

Summarizing entire professional activity both as university teacher and practitioner of business law, and organizing summative what I am proposing to undertake in the coming years at professional level, I appreciate habilitation thesis with the title PUBLIC POLICIES FOR BUSINESS. NORMATIV DIMENSION IN THE EUROPEAN CONTEXT the acknowledgement of the achievements as a researcher and university teacher so far, and the argument to continue deepening legal sciences research and outlining ideas and concepts in the field so complex and flexible of business regulation policy.

In my case, habilitation thesis means drawing new milestones for professional life, which I will compel more and better service for the researchers during their PhD. stage, the main beneficiary of future university activities, but also for the development of the regulatory framework, for the development of the Romanian administrative science.
