

ADDENDUM TO DOCTORAL STUDIES AGREEMENT

for the interruption of doctoral studies

Art. 1. Legal basis

Law no. 287/2009 on the Civil Code; National education law no. 1/2011; Government Decree no. 681/2011 regarding the approval of the Code of doctoral studies; Regulation no. 483/13 January 2020 of Babeş-Bolyai University regarding the organization and operation of doctoral studies.

Art. 2. This document constitutes an addendum to the Doctoral Studies Agreement No. _____.

Art. 3. The Parties of the Addendum to the Doctoral Studies Agreement

are the signatory parties of the Doctoral Studies Agreement as specified in art. 2, i.e.

(1) *Babeş-Bolyai University*, Cluj-Napoca, 1 Mihail Kogălniceanu Street (henceforth referred to as the *University*), as an accredited state institution of higher education under the Ministry of National Education, running doctoral degree programmes, legally represented by its rector, professor Daniel DAVID, PhD;

Art. 4. The purpose of the addendum to the Doctoral studies agreement

The purpose of this addendum is to regulate the terms and conditions of the contract between the signatory parts of the Doctoral studies agreement as specified in art. 2 throughout the doctoral student's interruption of the doctoral studies. The interruption period has a duration of _____ university semesters and starts with the first day of (check the box that applies) the first semester ; the second semester of the _____ academic year, i.e. starting (date) _____.

Art. 5. Duration of this Addendum to the Doctoral Studies Agreement

- (1) This addendum is valid throughout the doctoral student’s interruption of the doctoral studies as specified in art. 4.
- (2) The Doctoral studies agreement term is deferred throughout the duration of the interruption period specified in art. 4.
- (3) Throughout the interruption specified in art. 4, the Doctoral studies agreement specified in art. 2 is suspended.

Art. 6. Rights and responsibilities of the parties

- (1) The rights of the parties derive from the Babeş-Bolyai University Regulation regarding the organization and operation of doctoral studies and from the legal regulations in force.
- (2) Throughout the interruption of the doctoral studies specified in art. 4, all the rights and responsibilities of the parties, as they appear in the Doctoral studies agreement or derive from applicable regulations, are suspended.
- (3) In order to continue their doctoral studies, the doctoral student is required to contact the secretariat of the Institute for Doctoral Studies by the end of the interruption period.
- (4) Upon resuming their doctoral studies following the interruption, the doctoral student on tuition will pay, for each academic semester of doctoral studies subsequent to the end of the interruption, a semester tuition fee which will be calculated based on the annual tuition fee established by the University Senate for the current academic year.

Art. 7. The force majeure clause, as defined by law, protects from liability the party invoking the clause.
