

ADDENDUM TO DOCTORAL STUDIES AGREEMENT

for the extension of doctoral studies

Art. 1. Legal basis

Law no. 287/2009 on the Civil Code; National education law no. 1/2011; Government Decree no. 681/2011 regarding the approval of the Code of doctoral studies; Regulation no. 483/13 January 2020 of Babeş-Bolyai University regarding the organization and operation of doctoral studies.

Art. 2. This document constitutes an addendum to the Doctoral Studies Agreement No.

Art. 3. The Parties of the Addendum to the Doctoral Studies Agreement

are the signatory parties of the Doctoral Studies Agreement as specified in art. 2, i.e.

Art. 4. The purpose of this addendum to the Doctoral studies agreement

The purpose of this addendum is to regulate the terms and conditions of the contract between the signatory parts of the Doctoral studies agreement as specified in art. 2 throughout the doctoral student's extension of the doctoral studies. The extension period has a duration of (check the box that applies) two academic semesters ; four academic semesters and starts with the first day of the first semester ; the second semester of the _____ academic year, i.e. starting (date) _____

Art. 5. Duration of this Addendum to the Doctoral Studies Agreement

(1) This addendum is valid throughout the doctoral student's extension of the doctoral studies as specified in art. 4.

- (2) Throughout the doctoral student's extension of the doctoral studies specified in art. 4, the doctoral student is enrolled (check the box that applies) with state funding ; on tuition .
- (3) The Doctoral studies agreement specified in art. 2 is supplemented with the provision from par. (2) of this article and will be extended for the duration of the extension period specified in art. 4.

Art. 6. Rights and responsibilities of the parties

- (1) The rights and responsibilities of the parties are as they appear in the Doctoral studies agreement specified in art. 2, in accordance with the form of funding for the extension of the doctoral studies specified in art. 5 para. (2).
- (2) Throughout the extension of the doctoral studies, the doctoral student on tuition has the obligation to pay, for each semester of participation in the doctoral studies programme, including for the semester of the public defence of the doctoral thesis or the expulsion from studies, the semester tuition fee which will be calculated based on the annual tuition fee established by the University Senate for the current academic year.
- (3) In order to conclude their doctoral studies, the doctoral student is required to contact the secretariat of the Institute for Doctoral Studies by the end of the extension period.

Art. 7. The force majeure clause, as defined by law, protects from liability the party invoking the clause.
